HIGHLIGHTS

- Completion of placement of fully paid ordinary shares to raise \$8.0 million at \$0.35 per share, pre costs.
- Funds raised will be primarily used to advance the development of the Yarrabubba Iron-Vanadium Project and progress Project environmental approvals.
- The Company envisages the capital raised will fully fund activities through to delivery of the Yarrabubba feasibility study.
- Yarrabubba feasibility study scheduled for completion late Q3 2021.
- Share Purchase Plan (SPP) to eligible shareholders initiated to raise up to \$2.0 million at \$0.35 per share. SPP due to close on Friday 11 December 2020.

Technology Metals Australia Limited (ASX: **TMT**) ("**Technology Metals**" or the "**Company**"), is pleased to announce it has completed the placement of 22,857,142 new fully paid ordinary shares in Technology Metals (**Placement Shares**) to eligible sophisticated and institutional investors at \$0.35 per New Share (the **Placement**). The Placement will raise \$8.0 million (before costs).

The Placement was well supported by new and existing strategic and sophisticated investors. The Company is very pleased with the continued support of strategic domestic and international investors, including a further investment by Mr. Xu Jinfu, the Chairman and major shareholder of Guangzhou Tinci Materials Technology Co. Ltd (Tinci Materials).

Proceeds raised will be primarily used to fund activities and development at the Company's rapidly emerging Yarrabubba Iron-Vanadium Project ("**Yarrabubba**"), as well as progress environmental approvals at the Gabanintha Vanadium Project ("**Gabanintha**") and for working capital purposes.
